

# SSA #26

#### What is a Special Service Area?

For decades, the Special Service Area (SSA) program has provided communities with the financial means to create, maintain, and manage dynamic and thriving commercial corridors within the City of Chicago. SSAs are local property tax districts that provide funding for enhanced services and programs in neighborhoods throughout the city. These services, which include landscaping, sidewalk litter abatement, trash removal, sidewalk snow removal, area branding, neighborhood identification, business attraction, and providing rebate programs for businesses are important for maintaining thriving commercial corridors.

The City of Chicago's Department of Planning and Development (DPD) contracts with local nonprofits, typically chambers of commerce to act as service providers to administer the SSA program. A local Commission, appointed by the Mayor, oversees the service provider and determines SSA services and budgets annually. SSA funds are controlled locally, must stay in the community, and must be spent on services that achieve the mission of the particular SSA. Similar SSA programs enhance commercial corridors in over 50 areas throughout the City of Chicago.

### Who Makes up the Commission?

SSA commissioners are either owners or tenants of buildings, such as property managers or business owners, located within the SSA boundaries. These commissioners oversee and recommend the annual services, budget, and Service Provider Agency to the City of Chicago. A strong, creative, and diverse SSA Commission is an integral part of implementing successful programs and services within SSA #26.



#### How is the Edgewater Chamber of Commerce involved?

The Edgewater Chamber of Commerce is the sole service provider for SSA #26, and implements the annual work plan that is determined by the Commission. We assist in the recruitment and retention of SSA commissioners, to ensure the SSA is represented by a diverse and well-balanced group of people who are located in different parts of the neighborhood.







# REBATE **PROGRAMS**

SSA #26 funds various rebate and grant programs for businesses and property owners within the area. In 2020, the SSA administered a large number of programs resulting in tens of thousands of dollars in funding for support during a particularly difficult year.







# **2020 TIMELINE**

#### International Women's Day 3/8/2020

As part of this global celebration on March 8th, the 2020 theme of "Each for Equal" commemorated the cultural, political, and socioeconomic achievements of women. This annual event is a focal point in the women's rights movement, bringing attention to issues such as gender equality, reproductive rights, and violence against women. The Chamber's International Women's Day Crawl featured 8 woman-owned business locations that hosted 8 unique activations involving 19 participating businesses.

#### Virtual Restaurant Week 3/20/2020 - 3/30/2020

The goal of this program was to promote the take-out and delivery options of the amazing dining spots in Edgewater as restaurant kitchens cautiously reopened. Virtual Restaurant Week featured 28 restaurants and cafes with many featuring special dishes and deals created for this event. Earned media was received from three online magazines and two news outlets, including The Chicago Sun Times and Block Club Chicago. Restaurant week also inspired the Edgewater Restaurant Guide, which is now updated weekly on the Chamber website with Edgewater restaurant hours and information.

#### **Edgewater Essentials 5/28/2020**

As businesses began to pivot their operations to continue to service our community, so did the Chamber by providing our first fully online forum. Edgewater Essentials presented over 8 hours of programming that featured 21 businesses with 20 speakers with topics ranging from social media and communications to personal health and wellness. This event provided business owners and professionals an opportunity to showcase their expertise and attendees a chance to learn from their successes.

#### **State of Edgewater** 10/1/2020

Transit was at the heart of this program, focusing on the current station and track construction in the area. This online event engaged residents and small business owners with representatives from Walsh Fluor, CTA, and Metra providing updates and taking questions. Keynote speaker Olatunji Oboi Reed, President & CEO of Equiticity, spoke on racial equity with transportation disparity. A panel of local government officials including Rep. Cassidy, Ald. Osterman, Ald. Vasquez, Sen. Steans and Comm. Gainer closed the event with reports on area activities.





# 2020 TIMELINE (CONTINUED)

#### Reflections: An Edgewater Art Experience 10/1/2020 - 10/30/2020

Through this public art initiative, the Chamber showcased powerful messages of unity, social justice and hope with more than 20 art installations and mosaics. The art was presented on storefront windows, exterior business walls, and in windows of theatres and empty storefronts throughout the neighborhood. Local businesses owners collaborated with artists on the messages they wished to share with the community. The Chamber partnered with the Lytle House, Urban Art Restart, Paint the City, the Chicago Mosaic School, and the 48th Ward for the exhibit, highlighting their public art initiatives as well. Fifteen local businesses participated in the experience. Local street artists, professional muralists, mosaic world masters, fine artists and more created the artwork exhibited. Using an interactive online map, residents were invited to explore Edgewater in a new way to discover art, businesses and shops they may not have been familiar with. This program was featured on ABC, WGN and NBC news programming as well as in many online blogs and magazines.

#### **Holiday Mix** 12/18/2020

The Edgewater Chamber of Commerce curated performances from some of our talented friends and neighbors to present the Edgewater Holiday Mix, a collection of songs, stories and holiday cheer fit for the whole family. The program included storytelling, carols, crafts and messages from community members and the ECC Board of Directors..



# OTHER PROGRAMS

#### **Clark Street Banners**

In November 2020, 15 new banners were installed on Clark Street, between Ridge and Devon. These banners are sponsored by local businesses and provide increased visibility for them and help brand the neighborhood.

#### **Holiday Gift Guide**

Just in time for the holiday season, the Chamber created a guide to promote local businesses by highlighting a product or service that was a must-have for the season. This online guide included 27 local businesses who featured one item each. The guide was hosted on the Issuu website platform.

### **Open for Business**

The Chamber assisted in 50+ businesses joining the CTA's "Open for Business" campaign, which is a multi-year marketing effort. Business highlights during the Red,Purple Line Modernization program (RPM) will have a hyperlocal reach followed by a citywide focus in the coming years. Highlights during construction will have a hyperlocal reach followed by citywide focuses in the coming years. Keep an eye out for promotions and sign up is ongoing.

#### **Consumer Signage**

The Chamber assisted businesses with their customer communications, as 50+ Open for Business signs were placed in windows. In compliance with city regulations an additional 150 signs were distributed to mark the "social distancing, mask and hand washing" guidelines. As businesses began to open, over 25 businesses requested chalk markings or floor stickers with 6 feet indicators to allow for social distancing and 60 "We Are Open" stencils were applied in front of reopened businesses.
